**ORDER**

Government as per G.O. read first paper above granted 5 days Special Casual Leave to the Programme Officers, who attended the Special Camp of NSS volunteers for 10 days in view of Rule 5 Section II of Appendix VII, KSR.

Government of India as per paper read 2nd above have reduced the duration of the Special Camping Programme of NSS from 10 days to 7 days. The State Liaison Officer, State NSS Cell as per letter read 3rd above requested Government to reduce the number of Special Casual Leave granted to NSS Programme Officers from 5 to 3 days.

Government have examined the matter in detail and hereby reduce the number of days of Special Casual Leave from 5 days to 3 (three days) to the NSS Programme Officers who attend NSS Special Camp of 7 days every year.
